



TAX LEVY ORDINANCE CHAMPAIGN TOWNSHIP, ILLINOIS

ORDINANCE NO. 2024-2025-01

An ordinance levying taxes for all town purposes for Champaign Township, Champaign County, Illinois, for the year 2024 collectable in the year 2025.

BE IT ORDAINED by the Board of Trustees of Champaign Township, Champaign County, Illinois as follows:

SECTION 1: That the sum of TWO HUNDRED AND TWENTY-TWO THOUSAND FOUR HUNDRED DOLLARS AND NO CENTS (\$222,400.00) are hereby levied upon all property subject to taxation within the township as that property is assessed and equalized in order to meet and defray all the necessary expenses and liabilities of the township as required by statute or voted by the people in accordance with law, for such purposes as:

GENERAL TOWN FUND (CORPORATE) GENERAL ASSISTANCE FUND

For the fiscal year 2024-2025.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
