

Ordinance Number 2024-2025-01 Budget and Appropriation Ordinance

Champaign Township GENERAL TOWN FUND

An Ordinance appropriating for all **GENERAL** purposes for **CHAMPAIGN TOWNSHIP TOWN FUND, CHAMPAIGN COUNTY, IL** for the fiscal year beginning April 1, 2024 and ending March 31, 2025. Let it be ordained by the Board of Trustees of Champaign Township, Champaign County, Il.

Section 1: That the amounts hereinafter set forth, or so much thereof as may be authorized by law, and as may be needed or deemed necessary to defray all expenses and liabilities of CHAMPAIGN TOWNSHIP GENERAL TOWN FUND, be and the same are hereby appropriated for the GENERAL purposes of CHAMPAIGN TOWN FUND, CHAMPAIGN COUNTY, IL., as hereinafter specified for the fiscal year beginning April 1, 2024 and ends March 31, 2025.

Section 2: That the following budget containing an estimate of revenues and expenditures is hereby for the following funds:

Section 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance.

Section 5: That each appropriated fund total shall be divided among the several objects and purposes specified, and in particular amounts stated for each fund respectively in Section 2 constituting the total appropriations in this amount of Three Hundred Two Thousand, Two Hundred Eighty-Seven Dollars and Zero Cents for the fiscal year beginning April 1, 2024 and ending March 31, 2025.
